- The additional requirement of small track machines where ever required shall be worked out based on requirement of individual Division/Zonal Railway. 2.
- Portable DC Welding Generator may be procured on need basis with approval of CTE. Adequate number of spare machines (atleast 20% of the divisional requirement) may be
- kept at Divisional Depot to be used in emergencies/unit exchange for repair of STMs. "Off Track Tampers should be procured as per para no. 228 of IRPWM for maintenance
- of concrete sleeper track in terms of para no1408 1(c). These should be procured @ 1 set for each SSE(P.way) incharge / MMU-I unit. Working instructions given in chapter no.8.1 of IRSTMM-2005 should be followed."
